Summary of Conditions of Entry – Events

We look forward to welcoming you to the Princess, Regent and Comedy theatres, and to the Plaza Ballroom and Forum Melbourne. To ensure you have a safe and enjoyable experience, please be aware of the following conditions of entry to the Venue.

Marriner Group values the safety of all patrons. Security cameras operate throughout the Venue; you and your belongings may be searched on entry; and certain items are prohibited or restricted in what may be taken into the theatre or checked at the cloak room. A list of our security precautions is available on the full conditions of entry on our website or at the Box Office, and our staff can advise if you have any questions.

Please follow the directions of our staff and signage at the Venue. We are here to ensure everyone has a safe and enjoyable experience. You must pay close attention to, and comply with, all health and safety directions and protocols, including directions and protocols related to room capacity limits, health-based screening and physical distancing. If you do not comply with our directions and protocols, you may be asked to leave the Venue immediately without refund or further recourse.

Marriner Group practices the responsible service of alcohol. Any breaches of our liquor license or our responsible service of alcohol may result in refused service, refused entry or removal from the Venue.

You accept risks of entry. We aim to provide a safe Venue; however, you enter the Venue at your own risk and are responsible for any personal belongings in the Venue.

Stay at home if you are unwell. Please **do not** attend the Venue if you are experiencing or exhibiting any [symptoms of COVID](#), are required to be in quarantine or isolation, have recently returned from an [identified hotspot](#) or visited an [exposure site](#), or have been in contact (or suspect you have been in contact) with someone diagnosed with COVID. We reserve the right to refuse you entry to the Venue (or require you to leave the Venue) without refund or further recourse if we suspect you have not complied with this requirement. COVID-19 symptoms include:

- Loss or change in sense of smell or taste
- Fever
- Chills or sweats
- Cough
- Sore throat
- Shortness of breath
- Runny nose

We aim to provide a COVID Safe Venue. Our comprehensive COVID Safe Plan control measures includes frequent cleaning, physical distancing, and contact tracing to keep everyone in the Venue safe. Despite this, there remains a risk of transmission, and you enter the Venue at your own risk.



Please follow all safety protocols and requirements at the Venue. You agree to comply with any COVID related safety protocols or requirements notified by us while present at the Venue, including:

- a) health-based screening and monitoring (which may include but is not limited to temperature checks);
- b) wearing of approved fitted face masks where required;
- c) hand hygiene requirements (including hand sanitising);
- d) only sitting in designated seats or entering designated areas;
- e) physical distancing requirements (including while queuing);
- f) person density limits, including person limits for particular spaces and areas; and
- g) staggered entry and exit.

Practice physical distancing. Please ensure you are keeping a minimum distance of 1.5m from others at all times (or such other distance that we may nominate).

Practice good hygiene and respiratory practices. You must adopt good hygiene and respiratory practices at all times while in the Venue, including sneezing and coughing into your elbow or tissue (and disposing of tissues immediately), no spitting and regularly washing hands and using hand sanitiser. The wearing of masks may be a requirement on entry, exiting and when moving about the Venue. When not required, masks are strongly recommended when physical distancing is not possible.

Notify us of any COVID symptoms. If you develop any symptoms of COVID while attending the Venue or within 14 days of attending the Venue you must contact us immediately via e-mail on oh&s@marrinergroup.com.au or call us on (03) 9299 9990.

Provide your contact details to assist contact tracing. We may be required by law to collect your personal information and disclose this information to public health authorities to assist with contact tracing purposes. You must provide us this information if we request it. We will take all reasonable steps to keep your contact tracing information secure and free from unauthorised access or use.

Be Vaccinated. Government directions require all guests and suppliers aged 16 year and over to provide proof of full-vaccination status or a valid medical exemption to our staff to attend the event and enter our venues.
